- Cancellations made from 7 to 14 days in advance of the start date will incur a cancellation fee of 50&perc; of the total cost of the booking (1 to 7 days incur a cancellation fee of 75&perc; of the total cost of the booking, cancellations made within 24hrs of the start date will incur a cancellation fee of 100&perc; of the total cost of the booking
- If Mayo Adventure Experience has to cancel a booking for any reason the participants will be given as much notice as is possible and will be offered the choice of a full refund or a change of dates
- Participants of activities/courses/events booked with Mayo Adventure Experience will be
  expected to abide by all health and safety regulations and instructions as outlined by staff at
